If hard copy is allowed then a complete set of Bidding Documents may be purchased from the office Gaumul Rural Municipality, Bajura Bajra Bajura Gotree and the office Gaumul Rural Municipality, Bajura Bajra Bajura Gotree by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs.1000.0 till 26-01-2025 12:00 during office hours.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 26-01-2025 13:00 at the office of Gaumul Rural Municipality, Bajura Sudoor Pachism Province Nepal.  
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 80500 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]).
